Provided that if the investment advisory service is being provided by a separately identifiable department or division or a subsidiary, then such separately identifiable department or division or subsidiary shall include the words 'investment adviser' in its name;

- e. individuals registered as investment advisers shall use the term 'investment adviser' in all their correspondences with their clients
- 5. Your attention is particularly invited to Chapter III for General Obligations and Responsibilities which include risk profiling, suitability, disclosure to clients, etc, which shall apply to all investment advisory services provided by you.
- 6. You shall keep and maintain the books of accounts, records and such other documents as may be required by the Board under the Regulations from time to time.
